Dear Professor Martin,

acting for and on behalf of Dr hab. Tomasz Justyński, Professor of the Nicolaus Copernicus University in Toruń (power of attorney attached) I hereby request that you, the publisher of the blog available online: as http://www.bmartin.cc/dissent/documents/wronski/wronski, delete the blog entry titled Dean" (available online: "Accusations against a http://www.bmartin.cc/dissent/documents/Wronski/Wronski1307.pdf) in part or as a whole promptly, but in no event later than 3 days after receiving this summons. In its current form the blog entry infringes my Client's personal rights.

Parts of Marek Wroński's publication, translated by Anna Schneider, contain unambiguous allegations that Dr hab. Tomasz Justyński, professor of the NCU, plagiarised the monograph of Natascha Schulze. These allegations are false and infringe my Client's personal rights. The text on the website is not – contrary to the declarations – a translation of the article published in the Polish monthly "Forum Akademickie". In connection with the abovementioned publication on your blog, Marek Wroński was summoned to remove the effects of the infringement. He assumed his responsibility partially – only the title was adjusted but still at an unsatisfactory level. Moreover, there is still false information in the blog post that the Professor Justyński's monograph is a so-called "professorial book".

I hereby inform you that on the basis of a notification from Professor Dr hab. Wanda Stojanowska there are ongoing proceedings conducted by the Nicolaus Copernicus University's disciplinary ombudsman/prosecutor. Criminal proceedings were also initiated. In none of these proceedings Professor Tomasz Justyński was charged with plagiarism.

Some of the statements published on your website are misleading and expose my client to the loss of that trust which is essential in both scientific and academic work.

If you delete the defamatory publication promptly, my Client will not have any claims against you (as the publisher) linked to the infringement of personal rights.

I look forward to your positive and constructive approach to this problem.
