Judge attacks sacked academic

A FORMER University of Newcastle lecturer has been described as a 'vexatious litigant' costing the community up to \$20million from legal actions over the past two decades.

The bizarre case of Dr Michael Edward Spautz dates back to 1973 when the academic was appointed a senior lecturer in the university's Department of Commerce.

Between August 1973 and mid-1976 the university advertised three times for an appointee to fill the chair of commerce.

Dr Spautz applied twice but missed out.

In mid-1976 Dr Alan Williams was appointed, sparking a series of disputes which led Dr Spautz to accuse him of plagiarism.

The feud continued to escalate, prompting the university council to dismiss Dr Spautz on May 23, 1980. But the sacking set in train a

number of legal actions.

For more than 20 years Dr Spautz has been pursuing revenge through the legal system.

He has attempted to sue former university colleagues, his own lawvers, Newcastle Federal MP Allan Morris and even High Court Judge Michael Kirkby.

The one-man litigation machine has tied up the local, district, supreme and high courts with legal actions.

So litigious is Dr Spautz that Supreme Court Justice Barry O'Keefe has described him as a 'vexatious litigant'.

In his latest court appearance last month, Dr Spautz took on Attorney-General Bob Debus as he pushed to sue his former solicitor, two senior counsel and a junior counsel.

He alleged his legal team had failed him, accusing them of everything from negligence to fraud and deceit.

But Justice O'Keefe was unimpressed, dismissing Dr Spautz's applications and expressing disbelief at his legal

'Litigation has become a way of life for him,' the judge said.

'He revels in it. He enjoys the personal discomfiture and cost which his campaign of litigation brings to those whom he

'He has even considered converting his campaign into a crusade.'

Justice O'Keefe estimated Dr Spautz's legal actions had cost Newcastle University more than \$12million, not including the costs to individuals and the legal system which could bring the tally to \$20million.

But because Dr Spautz was 'on the dole' there was no prospect of costs being recouped.

Dr Spautz has lost cases in the Supreme Court in 1991, Court of Appeal in 1994 and High unfit' Court in the same year.

At the time of the latest Supreme Court hearing his tally of actions, suits, applications, prosecutions and appeals in various courts was approaching 50.

Michael Edward Spautz: • 1973: Dr Spautz appointed senior lecturer in Newcastle University's Department of Commerce.

1976: Dr Alan Williams appointed chair of commerce, sparking disputes with Dr Spautz.
